On 07/02/2024, the entries below on the Sanctions List of individuals and entities subject to the assets freeze, travel ban, and arms embargo set out in paragraph 1 of Security Council resolution [2610 \(2021\)](#) were amended following the 2022 Annual Review conducted in accordance with paragraphs 90 and 91 of resolution [2610 \(2021\)](#).

The following technical amendments were implemented on all the entries below: in the field “**Other information**”, text was added as follows: Review pursuant to Security Council resolution [2610 \(2021\)](#) was concluded on 30 October 2023.

Significant personal wealth, which could be used for regime purposes. Her sister Fatima FARKASH is married to ABDALLAH SANUSSI, head of Libyan military intelligence. As of 31 January 2024, she is no longer subject to paragraph 15 of resolution 1970.
